Bids are invited online through GeM Portal for auction of Unserviceable Condemned items/ Equipment's/ Electronic items from the authorized and eligible bidders on **"as is where is basis"**. The bids will be received only through GeM portal (Forward Auction) (<https://forwardauction.gem.gov.in/eprocure/home>) only and shall be opened as per provisions of GeM.

The items shall be sold to the bidder who will quote the consolidated highest rates. The bids are invited for the whole lot (i.e. all the items contained in the list of obsolete items as detailed at Annexure-I) as a whole and no bid would be accepted for any part of the same.

a.	No part lifting of the items shall be allowed.	
b.	Conditional bids shall not be entertained.	
c.	No claim for damage done by the way of theft, fire or any other unforeseen calamity will be entertained after realizing full payment against the unserviceable items.	
d.	Ground rent charge @ 1% of quoted amount per day will be charged if buyer fails to remove the lot within given time frame as specified in the office order. However, in case extra time is required, it shall be under the discretion of competent Authority.	
e.	The lifting of items must be done during the hours/days intimated by this Board to the successful bidder after taking necessary approval of the Competent Authorities.	
f.	The lifting of the items shall be done without damaging the premises roads drains etc. The buyer shall compensate the damages, loss etc, in the event of any occurrence otherwise. The buyer shall take the responsibility to set right any damages caused during lifting of the materials, to the satisfaction of the concerned authority.	
g.	No selection or sorting whatsoever of the goods will be allowed. The entire lot should be cleared by getting proper gate pass from Technology Development Board.	
h.	All labour, tools and equipment for loading the items from site to buyer's trucks with all leads, lifts, etc. shall be at the cost of the buyer.	
i.	The buyer is subject to the security rule of seller in force while in the seller's premises. The purchaser/s, their workmen agents or representatives shall not commit any nuisance, theft or indulge in any antisocial activities in the seller's premises and the purchaser shall be liable for the good conduct, safety & discipline of his workmen. q.	The Technology Development Board reserves the right to postpone/withdraw/cancel the tender without assigning any reasons whatsoever. No correspondence shall be entertained in this regard.
